CHANGES IN THE SALE OF LIQUEFIED PETROLEUM GAS (LPG)

On June 12th, 2019, the Supplies Control Unit (SCU) in the Ministry of Investment, Trade and Commerce issued a press release which introduced the following:

- 1. Wholesale prices for Liquefied Petroleum Gas (LPG); and
- 2. Retail prices for LPG by end user.

In an effort to reaffirm the sale of LPG by volume and clarify any misinterpretation that may exist, the SCU sees it fit to hereby inform the general public that the price paid for LPG is determined solely by the quantum purchased. This change now establishes threshold/limits for the sale of LPG by volume for both maximum retail and wholesale sales regardless of the end user. The SCU therefore informs the general public that this change took effect on **Friday August 30, 2019**.
