The Minister may make regulations -

(b) "for regulating or prohibiting the production, treatment, keeping, storage, movement, transport, distribution, exportation, importation, sale, purchase, use or consumption of articles or goods of any description, and, in particular, for controlling the prices at which such articles may be sold;

The SCU hereby informs those partaking in this illegal activity to desist as they are contravening the Supplies Control (Prices) Regulations (Statutory Instrument No. 88 of 2020). Continued violations will result in penalties being pursued to the full extent of the law.
