Contributing factors include but are not limited to record heat in the US West Coast, production outages in the US Gulf Coast as result of Hurricane Ida and increasing international demand for liquefied natural gas (LNG).

The general public is advised that the prices established for imported LPG are based on the mixtures of 70:30 (Propane: Butane) only as per requirement of the Belize National Standard Specification for Liquefied Petroleum Gas (LPG) BZS 21:2012.
